Provide full depth color EPDM & Binder from with mesh covering trench drain - surface to stretch from track edge to field edge and provide a monolithic appearance. Permeable qualities of the material are to allow free flow drainage of water into the trench drain. Scope includes more surface than that originally specified but provides a better solution that will prevent tearing and delaminating.
