#### MEMORANDUM OF AGREEMENT

The undersigned representatives of the Randolph Township Board of Education (hereinafter the "**BOARD**") and the Randolph Township Administrators Association (hereinafter "**RTAA**"), having entered into collective negotiations for a successor agreement to the Collective Negotiations Agreement covering the period from July 1, 2006 through June 30, 2009, herewith agree, subject to ratification by the **BOARD** and the **RTAA** membership, as follows:

- 1. The term of the new Agreement shall be from July 1, 2009 through June 30, 2012.
- 2. Salaries shall be increased as follows:

a. Effective July 1, 2009, salaries for bargaining unit members shall be increased by 3.5%, including all increments, over the 2008-2009 salary levels;

b. Effective July 1, 2010, salaries for bargaining unit members shall be increased by 3.5%, inclusive of all increments, over 2009-2010 levels;
c. Effective July 1, 2011, salaries for bargaining unit members shall be increased by 3.5%, inclusive of all increments, over 2010-2011 levels;
d. Salary increases shall be computed on employees active on role as of June 30, 2009.

- 3. Effective the 2009-2010 school year, instructional supervisors may be assigned one (1) instructional period per day.
- 3(a) The Board of Education shall adopt a resolution providing a \$4000 stipend for RTAA bargaining unit members who are assigned an instructional load for the first semester of the 2009-2010 school year. That stipend shall not be provided after that semester.
- 4. The <u>Recognition Clause</u> (Article I) shall be amended to:
  - a. Delete "Assistant Director of Special Services";

b. Delete "Director of Pupil Personnel Services" and substitute "Director of Guidance".

- 5. Effective November 1, 2009 or as soon thereafter as possible health insurance benefits shall be amended to:
  - a. Eliminate traditional plan coverage;

b. Increase prescription co-pay to \$10 for generic and \$20 for brand name.

- 6. Effective July 1, 2009, bargaining unit members shall have four (4) personal days which, if unused, shall be added to the employee's sick leave bank.
- 7. <u>Amend Article XIX to include the following:</u>

"All other RTAA members (other than supervisors assigned to teach a class) will teach one (1) Randolph academy class of two (2) hours in length over the course of this Agreement. The content of such

professional development will be at the discretion of the administrator and based on curriculum, building goals and Board of Education goals".

8. Article V – <u>Management Rights</u>. <u>Amend the first sentence of Section A.</u> to read as follows:

"The Randolph Township Board of Education on its own behalf and on behalf of the electors of the District hereby retains and reserves unto itself, without limitation, all powers, rights, authority, duties and responsibilities conferred upon it and vested in it by the laws and constitutions of the State of New Jersey and the United States including, but without limiting, the generality of the foregoing the right...."

9. Article VIII.A.1. of the Agreement shall be amended to read as follows:

"An administrator shall have the right to review the contents of his or her personnel file <u>by scheduling an appointment with the Personnel Director</u> which shall be granted within 2 business days of the request. Each shall be entitled to be accompanied by a representative of the RTAA during such a review".

10. Article XVI. <u>Temporary Leaves of Absence:</u> Amend section A (2) to include grandchildren

Add new Section E. to read as follows:

"E. Leave Benefits provided under this Article shall satisfy but shall not be in addition to leave benefits available pursuant to Federal and State Family and Medical Leave statues. To the extent that any provision of this Article is inconsistent with the requirements of Federal and State Family and Medial Leave statutes, the statutory language shall control".

- 11. Article XVIII. Sabbatical Leave delete in its entirety.
- 12. Article XIX shall be amended as follows:
  - a. Amend Section A.5. shall be amended to read as follows:

"All requests by administrators for approval of courses must be submitted through the Principal to the Superintendent as follows..."

b. Amend Section A.8. shall be amended with the addition of the following language:

#### "That agreement shall be signed at the time the application for tuition reimbursement is made".

c. Amend Section B. shall be amended to read as follows:

"Expenses shall not exceed limits established by the New Jersey Department of Education and the New Jersey Office of Management and Budget".

d. Amend Section C. Amend to read as follows:

"Subject to the approval of the Superintendent, the professional development of administrators may involve attendance at National, State and Regional professional meetings, conferences, conventions and workshops and may be reimbursed for **documented expenses in accordance with rules established by the New Jersey Department of Education and the New Jersey Office of Management and Budget"**.

e. Amend Section D. to read as follows:

"Transportation for interschool and other school business travel shall be compensated at the rate established by the New Jersey Department of Education and the New Jersey Office of Management and Budget".

13. Article XXI Section A (5)

Amend to read as follows: the cap for sick time payout will be 16,000 in 09-10; 17,000 in 2010-2011; and 18,000 in 2011-2012.

14. Article XX Section B(5)

Amend as follows: RTAA members employed as of June 30, 2009, will be paid longevity of \$300 for every five (5) years of service. The longevity calculation will become part of the employee's base pay as of June 30, 2009. This new base salary will be used to calculate future pay increases per the contract.

Longevity will cease to be paid after the 2009-2010 fiscal year.

15. Article IV Section A(1)

Add the following language: A calendar will be developed annually between the RTAA and the Personnel Department delineating the 219 day work year.

16. All other provisions of the predecessor Agreement shall be carried over without change.
