Mrs. MacKay thanked the exceptional candidates and announced the Board's intention to appoint Ronald Conti to the vacant Board seat. Mr. Conti will be sworn in at the March 18, 2014 Board meeting.

Superintendent's Report

HIB School District Report was presented to the full board by Dr. Browne. The report will be posted on the district's web site as well as the district's paperless website.

Education:

 Ms. Anne Standridge requested more board member participation at committee meetings.

Policy:

 Mr. David Rosenblatt: Committee meetings will be scheduled quarterly but be flexible if current issues came to the forefront.

Finance, Facilities and Transportation

- Referred to policy committee the review of the practice of non-district's entities collecting gate receipts that are not directly accountable to the district.
- Announced that the recently completed Facility Study will be deemed a security item with critical district infrastructure information and the information should not be used for public consumption
- Discussed a proposed change to the traffic pattern at the high school.
 Drawing, safety issues and concerns would be looked at by the district administration and presented at the next FFT meeting.
- Tentative Budget highlights were presented to the Board and future budget meetings were highlighted by the FFT Chair.
- The board discussed the exchange of information and its availability between committees and board members.
- The board discussed the reasonableness of what an appropriate tax levy should be. Board consensus is that the levy should remain at a 2% increase in the local tax levy.

Liaison Reports

Ms. Pascale updated the Board on a recent PAG meeting. She informed the Board of upcoming events sponsored by the special education department.

Public Discussion

Randolph resident was pleased to hear the tax levy will be 2%. He commented that future development planned in town will impact the school facilities and increase student enrollments. He commented on the function of Booster Clubs in the district and how they have benefited and enhanced the programs of the district. He expressed that if gate proceeds which currently go to the Boosters were directed to the general fund; the receipts could be diluted resulting in less impact to specific programs.

Another resident expressed disappointed that Board members are not as active at the committee level as she felt they should be. She encouraged the Board to be present during the Town Council meetings.

Former board member expressed concern that documents are not being shared with the full membership. She commented on her efforts with the Randolph Education Foundation and the recent success in raising approximately \$15,000 for the benefit of Smart Music at the middle school.

Another resident inquired about full day kindergarten and requested that the district actively pursue its implementation.

Old Business

Mr. Matos inquired about the benefit on GPA from AP courses. Dr. Browne updated the Board on the changing SAT and ACT testing requirements.

New Business

Mr. Matos requested more detail of the traffic pattern change at the high school. Dr. Browne requested Mr. Neves, Mr. Ruiz and Mr. Hurd to present the benefits to the FFT committee.
