- 1. Said Board agrees that the Board of Directors of the Essex Regional Educational Services Commission (ERESC) shall provide home instruction services to public school students. Services shall be provided at the place of confinement.
- 2. The terms of the Agreement shall be in effect from July 1, 2009 through June 30, 2010.

B. BILLING AND PAYMENT

- 2. Home instructors will meet with the student and parent(s)/guardian to arrange agreeable scheduled instructional periods.
- 3. Materials and assignments should be provided to the parent by the school district.
- 4. Said district will determine the amount of time home instruction will be provided in accordance with district policy and procedure.

- 5. Home instructors will be responsible for submitting all completed assignments, tests, progress reports, grades, etc. to the district contact person(s) upon the completion of the assignment unless otherwise agreed upon.
- 6. The ERESC will assist the district in meeting all state required guidelines, policies and procedures regarding home instruction services.
