Whereas, the Board of Education of RANDOLPH has the authority to employ outside agencies to provide necessary and appropriate IDEA-B services for the classified students attending nonpublic schools in the DISTRICT; and

NOW, THEREFORE, the parties agree as follows:

First: The ERESC, in consideration of the making of this Contract for the 2009-2010 school year, agrees to be paid hereunder by the District as the maximum and full compensation. ERESC shall provide services as needed during the 2009-2010 school year to classified students who are attending nonpublic schools in the District. The District shall provide the ERESC with the services to be provided after consultation with the nonpublic school administrators. The District shall provide the ERESC in writing with the proportionate share allocated for the nonpublic schools. If the District chooses to have the ERESC responsible to expend the carryover monies from the previous school year, the District must provide to the ERESC the amount of carryover in writing.

Second: The District shall remit payment to the ERESC after the above-mentioned services have been rendered. Payment is conditioned upon proper execution by the ERESC of the District's vouchers and other documents which may be required for the proper fiscal management of the public school District.

Third: This Contract may be terminated by either party upon giving thirty (30) days written notice. In the event of termination, the ERESC shall be entitled to payment for services performed up to the date of the notice of termination.

IN WITNESS WHEREOF, the Board of Education of RANDOLPH, in the County of MORRIS, and the Board of Directors of the ERESC have, by resolution, directed that their respective presidents and secretaries must affix to this agreement, a certified copy of the board resolution approving said Agreement.
