provide necessary and appropriate IDEA-B services	for the classified students attending nonpublic schools

NOW, THEREFORE, the parties agree as follows:

<u>First</u>: The ERESC, in consideration of the making of this Contract for the 2009-2010 school year, agrees to be paid hereunder by the District as the maximum and full compensation. ERESC shall provide services as needed during the <u>2009-2010</u> school year to classified students who are attending nonpublic schools in the District. The District shall provide the ERESC with the services to be provided after consultation with the nonpublic school administrators. In turn, the ERESC shall maintain ongoing communication with the nonpublic schools regarding the IDEA services. The District shall provide the ERESC in writing with the proportionate share allocated for the nonpublic schools through the ARRA funds. Also the district shall be responsible for complying with ARRA regulations as to how funding is spent and direct the ERESC accordingly. The ERESC shall be available to provide any reports needed for compliance.

<u>Second</u>: The District shall remit payment to the ERESC after the above-mentioned services have been rendered. Payment is conditioned upon proper execution by the ERESC of the District's vouchers and other documents which may be required for the proper fiscal management of the public school District.
