Whereas, the Board of Education of _____ has the authority to employ outside agencies to provide necessary and appropriate IDEA-B services for the classified students attending nonpublic schools in the DISTRICT; and

NOW, THEREFORE, the parties agree as follows:

First: The ERES, in consideration of the making of this Contract for the 2009-2010 school year, agrees to be paid hereunder by the District as the maximum and full compensation. ERES shall provide services as needed during the 2009-2010 school year to classified students who are attending nonpublic schools in the District. The District shall provide the ERES with the services to be provided after consultation with the nonpublic school administrators. In turn, the ERES shall maintain ongoing communication with the nonpublic schools regarding the IDEA services. The District shall provide the ERES in writing with the proportionate share allocated for the nonpublic schools through the ARRA funds. Also the district shall be responsible for complying with ARRA regulations as to how funding is spent and direct the ERES accordingly. The ERES shall be available to provide any reports needed for compliance.

Second: The District shall remit payment to the ERES after the above-mentioned services have been rendered. Payment is conditioned upon proper execution by the ERES of the District's vouchers and other documents which may be required for the proper fiscal management of the public school District.

Third: This Contract may be terminated by either party upon giving thirty (30) days written notice. In the event of termination, the ERESK shall be entitled to payment for services performed up to the date of the notice of termination.

IN WITNESS WHEREOF, the Board of Education of _____, in the County of _____, and the Board of Directors of the ERESK have, by resolution, directed that their respective presidents and secretaries must affix to this agreement, a certified copy of the board resolution approving said Agreement.
